DIRECTIONS FOR USE
GOLF COURSES--Greens, Tees, and Fairways
ATHLETIC FIELDS
Standard Program: Apply 1.2 Kg of PRIMER 604 Granular Formulation/100 m². Apply monthly, beginning at least one month prior to the onset of weather conditions that usually contribute to the development of soil hydrophobicity. Rainfall or irrigation is necessary to release PRIMER 604 off its carrier. Irrigate before next mowing or leave baskets off.

GENERAL TURF
Maintenance Program: Apply 1.2 Kg of PRIMER 604 Granular Formulation/100 m². Reapply at monthly intervals or as required. Rainfall or irrigation is necessary to release PRIMER 604 off its carrier. Irrigate before next mowing or leave baskets off. If turf is under high stress, apply at 1.8 Kg/100 m².
