DIRECTIONS FOR USE

Standard Program:

Apply 185 ml/100m² of REVOLUTION in 8 L of water (6 fl oz./1000 ft² in 2 gallons of water). Apply monthly beginning at least one month prior to the onset of stress conditions. Irrigation should be applied before next mowing to enhance product movement into the soil.

Tank Mixing

REVOLUTION can be safely applied in a tank mix with a range of commonly used turf chemicals and fertilizers at rates not exceeding 185 ml. Note: Tank mix combinations containing REVOLUTION have not been tested on all varieties of every turfgrass species or under all possible growing conditions. If user is unfamiliar with the performance of REVOLUTION in tank mixes under user's growing conditions, a limited area of turfgrass should be tested prior to large-scale application.
